BY USING THIS SOFTWARE OR BY CLICKING THE "I AGREE" BUTTON OR ATTEMPTING TO LOAD THE SOFTWARE IN ANY WAY, (SUCH ACTION WILL CONSTITUTE A SYMBOL OF YOUR SIGNATURE), YOU ACKNOWLEDGE AND ADMIT THAT YOU HAVE READ, UNDERSTOOD AND AGREED TO ALL THE TERMS AND CONDITIONS OF THIS AGREEMENT. THIS AGREEMENT ONCE ACCEPTED BY "YOU"[as an individual (assuming you are above 18 years and/or having legal capacity to enter into an agreement), or the Company or any legal entity that will be using the software (hereinafter referred to as 'You' or 'Your' for the sake of brevity)] SHALL BE A LEGALLY ENFORCEABLE AGREEMENT BETWEEN YOU AND THIRTYSEVEN4, LLC, MEDINA, OHIO (hereinafter referred to as "THIRTYSEVEN4") AND YOU SHALL HAVE THE RIGHTS TO USE THE SOFTWARE SUBJECT TO THE TERMS AND CONDITIONS MENTIONED IN THIS AGREEMENT OR AS AMENDED BY THIRTYSEVEN4 FROM TIME TO TIME. 1. DEFINITIONS

- A. **"Distributors"** means the authorized distributors, agents, sub-distributors of Thirtyseven4, selling Thirtyseven4 range of products, including sales through Internet.
- B. **"License period"** means the period as more particularly described in Clause 4 of this Agreement or the Evaluation period in case of Trial version of the Software.
- C. **"Mobile/Mobile Device"** means the personal digital assistants, smart phones, hand-held devices, or other electronic devices for which the Software is specifically designed (for such system requirements as particularly described in the User manual)where the Software will be installed and/or used.
- D. **"Normal working hours"** shall mean 08:00 a.m. to 5:00 p.m. Eastern Standard timing (EST) on Working Days and "Working Days" means Monday's to Friday's, but excluding National observed holiday's.
- E. **"Support"** means the Technical phone/e-mail/chat support provided by Thirtyseven4 between Normal working hours which may or may not be chargeable to you.
- F. **"Updates"** means collections of any or all among virus definition files including detections and solutions for new viruses along with the corrections, improvements or modifications to the Software.

- I. **"You"** means the **"End User"** means:

- i. An individual (such an individual) installing/using/legally acquiring the Software on his/her own behalf and every other person (whether authorized or not by such an individual) who uses/has the possession of the Mobile on which the Software is installed and activated; or
- ii. B. **Activation/Reactivation using Internet services on Mobile Device**

- i. using Internet services on Mobile Device

In case Internet based activation, usage of Internet bandwidth will be chargeable as per your telecom service provider charges, if using GPRS. In case of WiFi Internet, the bandwidth usage will be chargeable as per the Internet Service Provider charges.

Short Message Service (SMS) Usage.

- A. If You have acquired the Software on a physical medium, the License period shall commence from the date of acceptance of this Agreement and activation of the Software upto the period that is specified on the package or for any additional period as specified by any authorized communication by Thirtyseven4.
- B. If you have acquired the Software via Internet, the License period shall commence from the date of acceptance of this Agreement and activation of the Software upto the period that is specified during acquisition of the Software via Internet or for any additional period as specified by any authorized communication by Thirtyseven4.
- C. If you have acquired the trial version of the Software (solely for evaluation purposes) without any charge, the License period shall be 30 days from the date of acceptance of this Agreement and activation of the Software (Evaluation period). You understand, agree and accept that the trial version does not entitle You any Updates and Technical support via the Internet and telephone after the evaluation period. 9. COLLECTION OF INFORMATION

- E. Any type of information for identifying the Media Access Control (MAC) address of the Mobile Device, Global Positioning System (GPS), International Mobile Equipment Identity (IMEI), Subscriber Identity Module Number (SIM) on which the Software has been installed.

- F. Any type of information for identifying the Internet Protocol (IP) Address and information required for effective license administration and enhancing product functionality and usability.
- G. You admit that the information/data as collected above can be used for analyzing, preventing and detecting the potential internet security risks, publishing any type of data/ reports/ presentations on the trends collected, sharing the data to create awareness with any organizations, vendors.

10. INDEMNIFICATION

The software, source code, activation code, license keys, documentation, systems, ideas, information, content, design and other matters related to the software, trademarks are the sole proprietary and Intellectual Property rights of Thirtyseven4 protected under the Intellectual property Laws and belongs to Thirtyseven4. Nothing contained in this Agreement grant to You any rights, title, interest to intellectual property, including without limitation any error corrections, enhancements, updates or modifications to the Software whether made by Thirtyseven4 or any third party. You understand and acknowledge that you are provided with a License to use the software subject to the terms and conditions of this Agreement.

13. GENERAL

- A. **Force Majeure.** Thirtyseven4 will not be liable for any delay or failure to fulfill its obligations hereunder that results from an act of God, war, civil disturbance, government policies, or other cause/s beyond its control. Provided that Thirtyseven4 shall endeavor to complete the task within a reasonable period after happening of any event as covered under such force majeure.
- B. **Legal Jurisdiction.** This agreement and any matter relating thereto shall be subject only to jurisdiction of Courts at Medina, Ohio and shall be interpreted as per the terms of the law/s for the time being in force in the state of Ohio. Any dispute which may arise out of this Agreement, breach of terms and conditions under this Agreement, shall be settled by direct negotiations between You and Thirtyseven4. In the case of failure to resolve the dispute in the manner set out above within 30 days from the date when the dispute arose, the dispute shall be referred to a panel of three arbitrators, with Thirtyseven4 appointing one arbitrator, You appointing one arbitrator and the arbitrators so appointed jointly nominating a third presiding arbitrator. The venue of arbitration shall be Medina, Ohio. Introduction to Thirtyseven4 Mobile Security

The Android platform is quickly becoming a very popular platform for mobile devices due to its cutting edge interface. It is frequently used users due to its data richness. Data security along with mobile security is of utmost importance. The primary concern, of course, is the risk of exposing sensitive data if a phone or removable memory card is either lost or stolen. There is also a threat of viruses to attack the phones through SMS hacks and other exploits. You can use Thirtyseven4 Mobile Security if you are really concerned about the safety of your mobile phones. A new approach to managing the protection of the device is implemented by Thirtyseven4 Mobile Security. You can enable and disable any components depending on the required functionality.

Thirtyseven4 has come up with mobile security for android phones, popular as Thirtyseven4 Mobile Security. For more information, please visit www.thirtyseven4.com.

Thirtyseven4 Mobile Security includes the following protection components:

Virus Protection- Protects the mobile device's file system against all types of infections. The Virus Protection component can be initiated when starting the operating system. It contains a memory resident scanner that verifies all open, saved and started files on the device, including on memory cards. Further, Virus Protection verifies all incoming files for the existence of known viruses. This feature is always enabled and can be used even prior to activating Thirtyseven4 Mobile Security.

Scanning the device - Scanning helps to find and neutralize any malicious objects on your device. You should always scan the device regularly to prevent the spread of malicious objects.

Anti-Theft – Anti-Theft protects the sensitive information on the device from unauthorized access when it is lost or stolen. It allows the blocking of the device in the event of theft or loss and, allows deleting confidential information and controls SIM card change. It also helps to determine the geographical location of the device.

Furthermore, Thirtyseven4 Mobile Security contains a set of service features. They are designed to keep the application up-to-date, enhance its performance and help users.

Updating the application anti-virus database - This function allows you to keep Thirtyseven4 Mobile Security virus database up to date.

Protection status - The status of the program's components is displayed on screen. On the basis of this information, you can assess the current status of protection of your device.

Call Block - Thirtyseven4 mobile security's call block allows you to define who can call you. Call block allows you to block all or just some specific numbers from calling on your mobile phone. You can block calls from All Non-Contact numbers, some specific contacts or non-contact numbers (Black List).

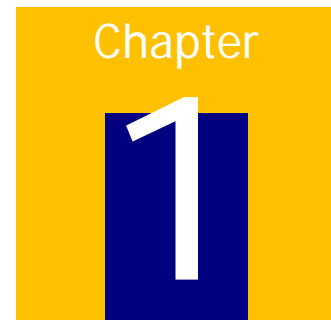
SMS Block - SMS block allows you to block unwanted messages from contacts, non-contacts, non-numeric senders and black list senders.

Event Log- Each of the application components has its own event log that includes the information on the component operation (for instance, data on a blocked object, scan report, updates etc.).

Thirtyseven4 Mobile Security has a simple installation procedure. During installation, read each installation screen carefully and, follow the instructions. Thirtyseven4 Mobile Security should be installed on an android mobile.

System Requirements

Thirtyseven4 Mobile Security is designed for installation on mobile devices. Your mobile phone should have supported versions and resolutions of Android as mentioned below.

Important

1. Please note that Thirtyseven4 Mobile Security Lifetime product registration is locked to specific device. It means if you have registered the product on a specific phone then you can only use Thirtyseven4 Mobile Security on the same device. Activation on a new device using the same product key will fail.
2. Thirtyseven4 Mobile Security Lifetime product does not support renewal.

Installation

To install Thirtyseven4 Mobile Security on the Android phone, please perform the following steps:

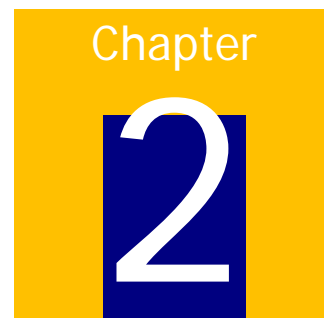
1. If you have downloaded the installer file from website directly on your Android phone, then tap **installer(.apk) file** to continue with installation. If you have downloaded installer file on PC then copy the installer file on Android phone. From the phone tap **installer (.apk) file** to continue with installation.
2. You will get a screen that will ask your consent to proceed with installation. Tap on **Install** to continue.
3. Thirtyseven4 Mobile Security is installed and it displays **Application installed** screen with **Open** and **Done** button.
4. Thirtyseven4 icon is displayed in **All apps**.
5. After Taping on **Thirtyseven4 Mobile Security icon**, Thirtyseven4 Mobile Security is opened.
6. **License agreement** is displayed.
7. Tap on **I Agree** to go to **Activation** screen.

Un-Installation

If you need to uninstall Thirtyseven4 Mobile Security due to some reason you can do so by following the steps below. However, you will have to deactivate it before uninstalling it.

If you wish to uninstall Thirtyseven4 Mobile Security, please perform the following steps:

1. Go to Android phone settings and open **Applications**.
2. Open **Manage Applications**.
3. Tap on **Thirtyseven4 Mobile Security**.
4. Tap **Uninstall**.
5. A prompt asks you **Uninstall Application**.
6. Tap **Uninstall**.
7. After Uninstallation is complete, **Finished** message is displayed.
8. Tap **OK**.

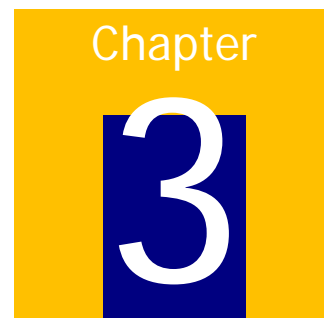

About Thirtyseven4 Mobile Security Dashboard

Thirtyseven4 Mobile Security Dashboard is very simple and convenient to use. The main elements of the dashboard are discussed below:

Notification Area

All the notifications are displayed on the topmost area of the Android phone i.e. Notification Area. Call Block, SMS Block and Virus Protection notification will be displayed here with their respective details.

Important Situations

Situations are the notifications that show status of the various events. Situations remind you of the various actions to be taken to use various features of Thirtyseven4 Mobile Security. Some examples of situations are given below:

Copy is not registered	Register Now!
Specific (30) days left for expiry	License period expires in 30 days! License period expires today!
License expired.	License period has expired. Renew Now!
Virus protection is ON	Phone is secure!

Not Updated since 7 days	Protection is out of date! Update Now!
Virus data base date is older than current date by 15 days	Protection is out of date! Update Now!

Features of Thirtyseven4 Mobile Security

All the features of Thirtyseven4 Mobile Security are displayed on the dashboard and can be accessed directly. These features are as follows:

Call Block	Blocks calls from all non-contact numbers or some specific contacts or non-contacts. (Black List).
SMS Block	Allows you to block messages from contacts, non-contacts non-numeric senders and black list.
Anti -Theft	Protects mobile using secret code. It also helps you to remotely lock phone, block phone on SIM change, wipe data remotely and get device location.
Virus Protection	It is real time protection and scans mobile continuously when enabled, preventing spread of any virus infection.

Menu

Thirtyseven4 Mobile Security Menu deals with configuring the general settings of the application, tools for preventing virus infection and diagnosing the system, reports of the activities of the features and, access help and license details. The following menus are available:

Scan	Allows you to scan phone memory, memory card and installed applications.
Settings	Allows you to customize important settings of Thirtyseven4 Mobile Security.
Tools	Provides access to important tools for Update and Quarantine that can help you keep the system and its software protected.
Reports	Provides detailed logs of important activity performed by Thirtyseven4 Mobile Security.
Help	Provides vital information related to software and licensing information. Also provides support related details.

Using Thirtyseven4 Mobile Security

Thirtyseven4 Mobile Security, with its user-friendly Graphical User Interface (GUI), is designed with the focus to simplify the task of securing your mobile. Using Thirtyseven4 Mobile Security is simple as all the steps are very easy to perform. Thirtyseven4 Mobile Security can be accessed from the Home Screen. The Main Window or the Dashboard will serve as the interface to all the features of Thirtyseven4 Mobile Security. You can access Thirtyseven4 Mobile Security from the Home Screen in any of the following ways:

- By clicking **Menu** ->**All Applications** ->**Thirtyseven4 Mobile Security**.
- By clicking **Menu** ->**Add to Home** -> **App** ->**Thirtyseven4 Mobile Security**. (Icon is displayed on Home Screen)
- By clicking **Menu** ->**Add to Home** ->**Widget** ->**Thirtyseven4 Mobile Security**. (Widget is displayed on Home Screen)

There are various features in Thirtyseven4 Mobile Security. They are as follows:

Call Block

One of the biggest problems of having mobile phones is getting unwanted calls. Thirtyseven4 Mobile Security's call block feature allows you to define who can call you. You can put all the numbers you want to avoid in the black list of call block. Call block allows you to block all non-contact numbers or just some specific numbers from calling on your mobile phone. You can block calls from all non-contact numbers, some specific contacts or non-contact numbers (Black List). However, you will have to enter contacts in black list first if you want to block calls from those numbers.

In case you wish to enable Call Block on your mobile, perform the following steps:

1. Tap **Menu** on the application Dashboard.
2. Tap **Settings** option.
3. Tap **Call Blocking** option.
4. Tap on **Enable Call Block** button.
5. Select **Configure Black List** or **Block Calls from Non-Contacts**.
6. You can enable or disable **Notification** to show blocked calls on notification bar.



You need to enter contacts in black list first if you want to block calls from those numbers.

To Add/ Remove a sender to Black List, perform the following steps:

1. Tap **Menu** on the application Dashboard.
2. Tap **Settings** option.
3. Tap **Call Blocking** option.
4. Tap **Configure Black List**.
5. Tap **Menu** on the application Dashboard.
6. Tap **Add to Black List / Remove**.
7. Select the Contacts icon to add a contact in black list, else enter a number.
8. Check **Add To SMS Black List**. (If you wish to block SMS from that number)
9. Tap **Save**.

SMS Block

SMS (Short Message Service) is one of the most popular features of the mobile phone system. But sometimes it becomes a nuisance as you may experience a lot of unwanted SMS news, advertisements, offensive texts or marketing information. SMS block allows you to block messages from contacts, non-contacts, non-numeric senders and black list senders.

In Case you wish to enable SMS Block on your mobile, perform the following steps:

1. Tap **Menu** on the application Dashboard.
2. Tap **Settings** option.
3. Tap **SMS Blocking** option.
4. Select **ON/OFF** buttons for **Enable SMS Scan** and, **Block SMS Spam**.
5. Tap **Configure SMS Spam**.
6. **Configure SMS Spam** screen with different options is seen. Select the option of your choice to enable it:
 - Block SMS from Contacts
 - Block SMS from Non-Contacts
 - Block SMS from Non-Numeric senders
 - Configure Black List- (Add/Remove sender to black list)
 - Configure White List (Add/Remove sender to white list)
 - Notification (Shows blocked SMS on notification bar)



You need to enter contacts in black list first if you want to block calls from those numbers.

Anti-Theft

Mobile phones are miniature computers that everyone is using these days. A lot of important and sensitive data can be found in mobile phones. Just imagine what will happen if it was lost or stolen? You would want your device back or at least the important data to be wiped out. You can rejoice as Thirtyseven4 Mobile Security provides information to pre-defined mobile phone number(s) when your mobile phone is lost or stolen.

Thirtyseven4 Mobile Security's Anti-Theft feature protects your mobile when it is no longer in your possession. It allows you to lock down the device making it useless for someone else to use it. It helps you to Lock phone remotely, Block phone on SIM change, Remotely wipe data and Get device location.

Let us see how you can enable Anti-Theft by performing the following steps:

1. Tap **Anti-Theft** on Dashboard.
2. **Enable Anti-theft in just 3 steps** screen is displayed.
3. Tap on **Setup Anti-theft** button.
4. (Step 1) Enter **Secret Code** and **Confirm Secret Code**.
5. Tap **Next**.
6. (Step 2) **Choose two security Questions** of your choice. Enter correct answers for the same. (In case you forget secret code, security questions will help to reset secret code).
7. Tap **Next**.
8. (Step 3) Enter **Alternate Contact number** to be displayed on blocked device and to notify when SIM change.
9. Tap **Save**.
10. **Anti-Theft enabled successfully** message is displayed.
11. You can **View Demo** or tap **OK**.



- When the mobile is lost and SIM is changed, you get a message on the pre-defined mobile phone number. This message gives you information about the new mobile number.
- You can remotely lock phone, remotely wipe data and get device location by just sending the following messages from any mobile to your mobile.
 - To Lock Device Remotely:
BLOCK antitheft_secret_code
 - To remotely unblock phone:
UNBLOCK antitheft_secret_code
 - To get device location:
TRACE antitheft_secret_code
 - To Wipe Data Remotely:
WIPE antitheft_secret_code

Unblock Device

If your mobile phone gets blocked due to SIM change or remote lock, then you can unblock it by performing the following steps:

1. Tap **Unblock**.
2. **Enter Secret Code**.
3. Tap **Go**.

In case you forgot the Secret Code, you can still unblock the mobile and set new secret code. There are two ways in which you can unblock the device:

Unblock Using Forgot Code option.

1. Tap **Unblock**.
2. Tap **Forgot Code?**
3. Enter the valid answers to the security questions. Tap **Submit**.
4. **Change Secret Code** screen appears.
5. Enter **New Secret Code** and **Confirm** it.
6. Tap **Save**.

Unblock using recovery code option.

1. Tap **Unblock**.
2. Tap **Unlock using recovery code**.
3. **Unblock** Screen Appears. Go to the **link** and obtain recovery code. Enter **Recovery Code**.
4. Tap **Submit**.
5. **Reset Secret Code** screen appears. **Enter New Secret Code** and **Confirm** it.
6. Tap **Next**.
7. **Change Security Questions** screen appears. **Choose Questions** and **Answers**.
8. Tap **Save**.

Forgot Answers to Security Questions?

In case you forgot the answers to security questions, you can still unblock the device and reset the security questions by performing the following steps:

1. Tap **Unblock**.
2. Tap **Forgot Code?**
3. Enter the valid answers to the security questions. If you enter wrong answers and tap **Submit**, **Invalid Information** screen appears.
4. Tap **Forgot Answers?**
5. Go to the **link** and obtain recovery code. Enter **Recovery Code**.
6. Tap **Submit**.
7. **Reset Secret Code** screen appears. **Enter New Secret Code** and **Confirm** it.
8. Tap **Next**.
9. **Change Security Questions** screen appears. **Choose Questions** and **Answers**.
10. Tap **Save**.

Virus Protection

Mobile phones are extensively used as end point devices for communication and browsing the web or checking emails. Mobiles have become the pocket PCs and have a wide range of functionality. Mobiles are prone to Virus and Malware attacks as you surf the net. Let us see how Thirtyseven4 Mobile Security's Virus Protection feature can help you. Virus Protection menus and their functions are discussed below:

Scan Settings	Allows to Repair, Delete or Skip when virus is found.
Virus protection	Set virus protection ON/OFF.
Virus Protection Settings	Allows to Repair, Delete or Skip when virus is found.
Quarantine	Deletes quarantine files after 7 days, 30 days or 45 days.

Enable Scan Settings

If you wish to enable Scan Settings, Perform the following steps:

1. On the application Dashboard, tap on the device **Menu** button.
2. Select **Settings** option from the Menu options.
3. Tap on **Scan Settings** option.
4. Tap **Scan Settings**.
5. Select **Repair/Delete/Skip** (Action to be performed when virus is found.)

Enable Virus Protection Settings

If you wish to enable Virus Protection Settings, Perform the following steps:

1. On the application Dashboard, Tap on the device **Menu** button.
2. Select **Settings** option from the Menu options.
3. Tap on **Scan Settings** option.
4. Set **Virus Protection ON** to enable it.
5. Tap **Virus Protection Settings**.
6. Select **Repair/Delete/Skip** (Action to be performed when virus is found.)

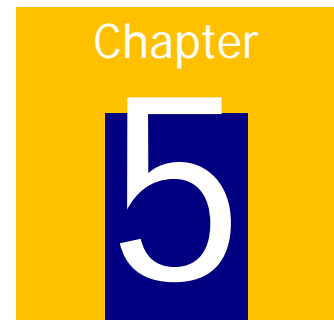
Enable Quarantine

If you wish to enable Quarantine, Perform the following steps:

1. On the application Dashboard, Tap on the device **Menu** button.
2. Select **Settings** option from the Menu options.
3. Tap on **Scan Settings** option.
4. Select **Quarantine**.
5. Set **Delete quarantine files ON** to enable.
6. Select different options from dropdown. E.g. **After 7 days**, **After 30 days** or **After 45 days**.



- Repair- All infected files are repaired.
- Delete- All infected files are deleted.
- Skip- All infected files are skipped.



Menu

Menu is an important section of the Thirtyseven4 Mobile Security dashboard. It deals with configuring the general settings, tools, reports and access to help and license details. The following menus are available:

Scan	Allows you to scan for viruses.
Settings	Allows you to customize all the important settings of Thirtyseven4 Mobile Security.
Tools	Provides access to important tools that can help you to keep the system and its software protected.
Reports	Provides detailed logs of important activity performed by Thirtyseven4 Mobile Security.
Help	Provides vital information related to software and licensing information. Also provides support related details.

Scan

You can scan phone memory, memory card and installed applications for viruses and malware using the Scan option of the Thirtyseven4 Mobile Security. This will help you to keep your device protected.

If you wish to scan phone memory, memory card and installed applications of your mobile phone, please perform the following steps:

1. On the application Dashboard, tap device **Menu** button.
2. Select **Scan** option from the Menu options.
3. Tap **Full Scan / Scan Memory Card** to begin the scan.
4. On completion of the scan, tap **View Detail** to see report in case any threat is found. If no virus is found, **No Threat Found** message is displayed.
5. In case any infection is found in already installed application, then you need to take action to resolve it. Tap **Resolve Now** button and select the application. Choose either **Skip** or **Uninstall** options.



- Full Scan- Scans phone memory, all the installed applications and memory card.
- Scan Memory Card- Scans only memory card.

Settings

Settings allow you to change all the important settings of Thirtyseven4 Mobile Security. You can configure Scan Settings, SMS Blocking, Call Blocking, Anti-Theft, and General Settings. General settings allow you to have password protection to access settings. You can also change the already configured settings and the Secret codes from settings button.

Scan Settings	Scan Settings- Action to perform when malware is found. (Repair, Delete, Skip) Virus Protection- Sets virus protection ON/OFF. Virus Protection Settings- Action to perform if virus is found. (Repair, Delete, Skip) Quarantine- Delete quarantine file after specified days.
SMS Blocking	Enable/Disable SMS Scan, SMS Spam Protection and Configure SMS Spam Protection.
Call Blocking	Configure Call Block settings for- All Non-Contact Numbers, some Specific Contacts or Non-Contact Numbers (Black List).
Anti-Theft	Configure Anti-Theft - Remotely lock phone, Block phone on SIM change, Remotely wipe data and Get device location.
General Settings	Configure General Settings- Password Protection, Internet Settings and Report Settings.

To change Settings of your Thirtyseven4 Mobile Security, you can perform the following steps:

1. On the application Dashboard screen, Tap on the **Menu** Button
2. Tap **Settings** button.
3. On the Settings screen, select **Scan Settings/ SMS Blocking/ Call Blocking/ Anti-Theft/General Settings** option from the list displayed.
4. Make the desired changes.



You can change the following Anti-Theft settings.

- Change Secret Code option allows you to change the secret code.
- Change Security Questions option allows you to change the security questions and their answers.
- Change pre-defined mobile phone number for Notify SIM Change.
- Change pre-defined message and contact numbers on Blocked Device.

Tools

Tools are one of the important features of Thirtyseven4 Mobile Security. You can update your copy of Thirtyseven4 Mobile Security for the latest virus database. The tools available with Thirtyseven4 Mobile Security, for diagnostic work and repair of the system, are as follows:

Update	Allows you to update to latest virus database updates.
Quarantine	Allows you to view Quarantined files.

Update

Thirtyseven4 Mobile Security automatically updates if it is connected to internet. You can also initiate manual update to protect your mobile from latest threats.

If you want to update Thirtyseven4 Mobile Security, you can perform the following steps:

1. On the application Dashboard, tap on the device **Menu** button.
2. Tap **Tools** option.
3. Select **Update** option to apply latest updates from Internet. If updates are available, it will show **Update Successful** message. In case there are no latest updates, it will show **Up to Date** message.

Quarantine

Quarantine is a specific folder where Thirtyseven4 Mobile Security places potentially malicious objects. You can view the list of objects that the application has moved to Quarantine. For every object, its full name and date of detection are specified on the list. Quarantined objects can either be deleted or restored.

To take action on Quarantined files, you can perform the following steps:

1. On the application Dashboard, tap on the device **Menu** button.
2. Select **Tools** option from the Menu options.
3. On the Tools screen, select **Quarantine** option. All the Quarantined files are displayed with their information. (File name, file path, date and time when the file was quarantine and the type of malware found in the file).
4. To Restore the file: Tap on the device **Menu** button, then **Select All** option and **Restore** or you can manually **Select** individual files and **Restore** them.
5. To Remove the file: Tap on the device **Menu** button, then **Select All** option and **Remove** or you can manually **Select** individual files and **Remove** them.



- Restore option returns the infected file to its original location.
- Remove option deletes the infected file.

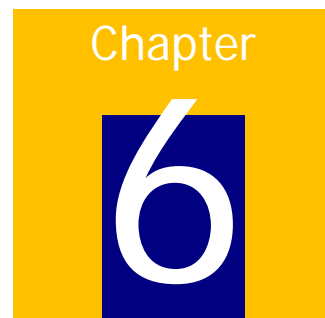
Reports

Reports provide detailed logs of important activity performed by Thirtyseven4 Mobile Security. Displays the Reports screen to the user with following options:

Blocked SMS	Displays the list of blocked SMS's.
Blocked Calls	Displays the list of blocked calls to the user. For every entry there is a list of last 10 calls, date and time details.
Anti-Theft	Displays Anti-Theft reports, e.g. For Phone block on SIM change, Remotely lock device, Remotely wipe data etc.
Scan Report	Displays Scan report with information of threat found, location and action taken.
Virus Protection	Displays Virus report with information of threat found, location and action taken.
Update	Displays details of updates taken for Virus Database.

If you wish to view reports, please perform the following steps:

1. On the application Dashboard, tap on the device **Menu** button.
2. Select **Reports** option from the Menu options.
3. On the Reports screen, select the option of your choice.



Help

Help menu provides you the required assistance to understand Thirtyseven4 Mobile Security better. Assistance, such as Web Support, Telephone Support, Email support and license information can all be accessed from the Help menu. The following menu items are available under the Help menu:
